

Forensics Module Skit

This skit provides the back-story for the crime solving activity that is part of the Forensics Module. Prior to beginning the presentation, select four students to read the parts of the Principal and Students. Alternatively, the teacher may read the part of the Principal and students read the Student parts. To make the skit more engaging, add in the name of your high school, rival high school, mascot, etc.

Principal: Good morning faculty and students! As you all know it is Homecoming Week at
<u>(your)</u> High School. The student activities club has been working around the clock on
final preparations for our Homecoming Dance, which will immediately follow the football game
against <u>(Rival)</u> High School this Friday evening. Since our schools are currently ranked
first and second in the state, we expect this to be a thrilling game, and the winner will surely be
front-runner for the state title. Therefore, we encourage you all to
(Pause, speaking to someone else.)
Wait what's that? Missing? Oh dear!
(To the students.)
It has come to my attention that our mascot, is nowhere to be found!
However, this is no accident. Coach found this note in a sealed envelope on the
50-yard-line of the football field this morning.
It reads:
To the Students of <u>(Your)</u> High,
The senior class at <u>(Rival)</u> High is proud to have pulled off its greatest prank yet. We have
taken, your precious mascot. If you want him back, your undefeated football
team will have to forfeit your game against <u>(Rival)</u> High on Friday. Otherwise,
stays here with us indefinitely.
Signed, <u>(Rival)</u> High Senior Class
We will consult with our school officer and the Principal of(Rival) High, but in the mean
time, we ask that you all remain calm and refrain from doing something you might regret.

We will instead rely on students from our forensics class to compare these samples to DNA samples taken from the ransom note envelope.
